I agree to having the following personal information collected and stored (either electronically or otherwise) for the purpose of assisting Moyobet and Moyo Casino to identify me:

- my name, gender, place of residence (and postal address), telephone contact, Passport/ID No., date of birth, and photo.
- this information will be stored until my self-exclusion ends, will be kept securely and will only be used by the venue to assist me to comply with my self-exclusion. This information will be destroyed when this Agreement has ended.

I further agree to Moyobet and Moyo Casino forwarding the above personal information to the Regulator i.e. Betting Control and Licensing Board (BCLB).

In consideration of my request to self-exclude:

- a. I agree not to enter the Moyo Casino, or any property under its control, or to visit any the Moyobet website, at any time for any purpose for the duration of my exclusion period.
- b. I understand that this exclusion request is indefinite, with a minimum and irrevocable period, that I must request to be reinstated once the minimum period has passed, that reinstatement request determinations shall be at the sole discretion of the Betting Control and Licensing Board, and that there is no guarantee that the request will be granted.

- c. I understand that violating the ban during my self-exclusion period will result in a complete forfeiture of winnings and immediate ejection from the casino or website.
- d. I understand that I will not be eligible for any promotional offerings, or to claim any winnings, prizes, points, rewards and/or gifts from the Casino or Moyobet (including play online and affiliated promotional sites) while I am excluded. I also understand that it may take up to 6 weeks to be removed from the marketing and mailing lists.

I understand and acknowledge that this self-exclusion request does not relieve me of any outstanding credit and/or markers owed to the Casino. If I have outstanding credit and/or markers owed to the Casino, these liabilities are due and payable under the terms of the credit agreement.

I hold harmless and agree to indemnify Moyobet, Moyo Casino and any of its partners, subsidiaries or instrumentalities for any liability related to this request, and for any liabilities related to my violation of this request. Specifically, I, for myself, my heirs, executors, administrators, successors and assigns, hereby release and forever discharge the above listed parties and their members, employees, officers and Directors from any and all claims in law or equity that I now have, or may have in the future, against all of any of the released parties arising out of, or by reason of, the actions, including gambling losses, that may occur upon my return to the Moyobet and Moyo Casino and all its associated gaming platforms including but not limited to The Hunt.

Upon receipt of this completed form, Moyobet will share your identifying information including this form with the Betting Control and Licensing Board (BCLB). Please be aware that through filling this form, Moyo flags you for both land-based gaming and online sports wagering and/or gaming, and will also exclude you from gambling or wagering in its premises and/or website. **ACCORDINGLY, YOU SHOULD BE AWARE THAT AS A CONSEQUENCE OF YOUR SIGNING UP FOR AN ONLINE SPORTS WAGERING BAN/SELF EXCLUSION, MOYO WILL BAN YOU FROM ALL OF ITS LAND-BASED PROPERTIES AS WELL AS ALL OF ITS ONLINE GAMING AND ONLINE SPORTSBOOKS. YOU COULD ALSO FORFEIT ANY REWARDS POINTS YOU MAY HAVE EARNED.**
